1. Opening session.

3. GICSV Work Plan 2021 - 2023. T. absoluta WG deliverables validation.

TS explains that GICSV Coordinating Group updated Work Plan for 2021-2023 biennium, deliverables were not substantially modified but CG appreciate if WG validate them. TS facilitates the review of tasks and deliverables and the WG concluded:

- 3.3.1. RPPOs confirmed the WG participants.
- 3.3.2 and 3.3.3. WG Coordinator indicates that it will be analyzed at this meeting.
- 3.3.4. Exchange information to keep GICSV website updated is a permanent task for this biennium.
- 3.3.5. "Guide for *Tuta absoluta* prevention and control". This task began in 2020 and is expected to be completed in 2021. WG agree include "detection" in the title, however, will be considered in the subject analysis.
- 3.3.6. "Projection of Latin American action plan", WG reviewed and modify this topic
 due to the nature and scope of nationals and regional action plans. The WG Coordinator
 highlighted the idea of incorporating all the components into the document that will be
 working and focusing it on the impact it will have on the countries. He also pointed out
 that WG should analyze how this document is going to be socialized with the countries.
 The issue will continue to be worked on.
- 3.3.7. WG is invited to suggest tasks of interest. There are no observations by the members.















4. Tuta absoluta WG meeting schedule

WG Coordinator proposes the following schedule and agenda for 2021 WG meetings and indicates that the objective is to work intensively in the "Guide for the prevention and control of *T. absoluta*" development in order to comply with the programmed and complete the document at the end of this year. It proposes as few meetings as possible and if necessary, additional meetings could be included.

WG discuss and agrees that it is convenient to focus on one topic, the "Guide", and maintain a meetings monthly schedule at the beginning of each month, although could be necessary specifics adjustments to proposed dates. With the objective of holding brief and executive meetings, the work dynamics will include the analysis and exchange of proposals and suggestions, prior to the meetings, by electronic means, to arrive at the meeting for final decisions.

WG members will send, to the Coordinator with a copy to the GICSV Coordinator and TS, comments, and suggestions regarding schedule dates (until Friday, June 11).

5. Review of table of contents of "Reference guideline to prevent and control T. absoluta".

WG Coordinator facilitates the review of the proposed content index for "Guide" (Annex II) and recalls that it was prepared and shared as a proposal in 2020 and was shared again with 2021 meeting call.

The Coordinator emphasizes that the content topics proposed for the "Guide" is open for WG comments, hoping to enrich it with RPPOs opinion and, through them, meet countries expectations.

WG analyze the need to define "Guide" objectives in clearly way, as well as to properly identify the document audience. WG point out that they are two important elements for the analysis of the proposed content.

The Coordinator points out that progress was made in objectives and audience development, as well as items I to IX: 9.5 of proposed table of contents, which will be shared once the contents have been agreed, however, the objectives and audience will be shared as soon as possible.

WG Coordinator proposes, as a strategy to advance faster in contents development, that each RPPO take one or a few chapters to develop. Considering there are many documents on *T. absoluta* with different approaches and scopes, the WG agrees that the "Guide" should include the most innovative aspects and differentiate itself from other similar documents.

WG agrees shared with the Coordinator, with copy to the TS and GICSV Coordinator, the members comments on the title and the proposed content (index) and a proposal of the chapters that each RPPO could take for its development. Comments and proposals could be sent until June 25.
