STATUS OF THE RESOLUTIONS OF THE THIRTY-SIXTH REGULAR MEETINGS OF THE EXECUTIVE COMMITTEE

I. General Information

The Thirty-sixth Regular Meeting of the IICA Executive Committee was held in San Jose, Costa Rica, from 23-24 August 2016. The Executive Committee was made up of the following countries: Argentina, Belize, Bolivia, Costa Rica, Dominica, Dominican Republic, Ecuador, Jamaica, Paraguay, Saint Lucia, United States of America and Venezuela¹.

Mr. Juan Carlos Baruja, Minister of Agriculture and Livestock of Paraguay, served as the Chair of the meeting, and Mr. Wendell Dennis, Deputy Director General of the Multilateral Affairs Division of the Foreign Agricultural Service (FAS) of the United States Department of Agriculture (USDA), serve as Rapporteur.

STATUS OF THE RESOLUTIONS OF THE THIRTY-SEVENTH REGULAR MEETING OF THE EXECUTIVE COMMITTEE

I. General Information

The Thirty-seventh Regular Meeting of the IICA Executive Committee was held in San José, Costa Rica, from 18-19 July 2017. The 2017 Executive Committee comprised the following Member States: Antigua and Barbuda, Argentina, Colombia, Costa Rica, Dominica, Ecuador, Mexico, Nicaragua, Panama, Paraguay, Saint Lucia and the United States of America.²

II. Status of the resolutions adopted by the 2017 Executive Committee
